



15-Year Limited Lifetime Residential Warranty

Color Guard® Inc. Upside Deck Ceiling products are warranted to be free from manufacturing defects that result in peeling, flaking, cracking or extreme amounts of fading or bleaching under conditions of normal use and service for the period of 15-years from the date the product was originally purchased. Color Guard® Inc. warrants that the product will snap together as designed for the limited warranty period. This warranty is extended to the original purchaser only and is non-transferable.

CONDITIONS NOT COVERED BY THIS WARRANTY

- This warranty does not cover costs of the installation, removal, reinstallation or shipment of product.
- Physical abuse, alteration, misuse, neglect or improper storage.
- Improper installation or installation not in strict adherence to instructions written by Color Guard® Inc.
- Damage to the vinyl resulting from movement and/or collapse of the ground or structure on which the vinyl is installed.
- This warranty does not apply if the vinyl product materials are painted, varnished or coated with any substance.
- Damage attributable to atmospheric pollutants, hail, lightning, hurricane, tornado, wind borne objects, earthquake, fire, mildew, casualty, or acts of God, building or ground settlement.

CLAIMS AND REMEDIES

If Color Guard® Inc. vinyl products are determined to have manufacturing defects which are covered by this warranty, Color Guard® Inc. will replace or repair the vinyl product containing the defect (labor not included).

Color Guard® Inc. will not be responsible for any costs incurred in the removal, replacement installation or reinstallation of the vinyl product.

Important - Any claims under this warranty must be made within 30 days after the defect was first discovered or reasonably could have been discovered.

All warranty claims must be submitted in writing to the address listed below and must describe the defect claimed. The homeowner **MUST** include a copy of the original purchase and the completed warranty claim form. When possible, photographs may also be submitted. If need be, an authorized Color Guard® Inc. representative will contact the homeowner to arrange a time to schedule an on-site inspection.
